**Objectives:** This one day event aims to share and discuss the findings from the PEGASUS project with stakeholders from Portugal and neighbouring countries as well as other countries of the EU, and their implications for future policy and practice. The event will focus on the value of collective approaches and ways to enhance social capital, levels of cooperation and trust between stakeholders. It is intended that these discussions should feed into the debate on how national and EU policies, including the Common Agricultural Policy, might evolve post 2020.

**Background:** PEGASUS is a multidisciplinary Horizon 2020 project (<http://pegasus.ieep.eu/>) whose aim is to investigate ways to enhance the provision of public goods and ecosystem services in EU agriculture and forests. Partners are drawn from 10 Member States and include ecologists, rural sociologists, economists, geographers, policy analysts from academic institutions as well as NGOs and think tanks.

**Context:** This event is part of a series of three seminars in different locations of the EU and focusing on different aspects of the study. The findings and lessons are the results from three year of participatory research and analysis. More specifically, the objectives of the seminar are to:

- Share the findings of the project from the 34 case studies carried out in 10 Member States and new EU maps showing the linkages between agriculture and forest management systems and the delivery of public goods and ecosystem services;
- Present the lessons and recommendations for policy and practice
- Receive feedback types from national policy makers and practitioners from different countries.
